



**'Iolani Alumni Association Board of Directors 2019
CALL for NOMINATIONS**

Six (6) Decade (two from the '70's and one each from the '80's, '90's, '00's and '10's) and five (5) At-Large Director positions on the Board of Directors of the 'Iolani Alumni Association are open for election this year as the incumbents' terms expire.

The Board, elected by 'Iolani alumni, consists of ten (10) Decade and twelve (12) At-Large Directors. The Decade Director positions are two for each of the decades, '00's, '90's, '80's and '70's, one each for the '60's and '10's.

Nominations for Directors: All members of the 'Iolani alumni community may nominate candidates (self nominations are permitted) by submitting the names of qualified candidates accompanied by the signature of the candidate and any ten (10) alumni. Please indicate whether the nomination is for a Decade Director or an At-Large Director position. Nomination forms may be requested by contacting Alumni Relations Manager, Shari Tapper '90 at stapper@iolani.org or (808) 943-2309.

- A Member of the Association is any graduate of 'Iolani School and all former students who attended 'Iolani School for at least one year and whose class has graduated.
- Qualified Decade Director candidates are members from the decade in which the candidate graduated, or whose class graduated, i.e. the ten-year period beginning on years ending in zero. For example, a candidate for the '60s Decade Director must have graduated or been a member of a class which graduated between 1960 and 1969 inclusive. Decade Directors may only be elected by members from the same decade.
- Qualified At-Large Director candidates may be any member without respect to the year of graduation. At-Large directors are elected by all members.

Candidates should submit a brief bio that includes their class year, current career or job, why the candidate is interested in serving on the Board, and previous and current involvement with school or alumni activities.

Voting for the Directors will occur online with each Member receiving via email a unique code or weblink to vote. Information about the candidates will also be posted on the ballot and website at www.iolani.org/alumni. You will not receive printed ballots through the mail, unless requested in writing. Following completion of nominations, the ballot and information regarding the upcoming election and the voting process (e.g., the designated website and dates for voting) will be emailed to you at your email address on-file with the Advancement Office ("AO"). If you would like to submit or update your email address to be kept on file with AO, please contact Shari Tapper. Any new or updated addresses received by June 23, 2019 will receive an online ballot. Completed ballots must be submitted online or received via mail by Sunday, June 30, 2019.
